- I hereby agree to breed my mare _____ Reg. No. _____ to _____ for the _____ season at \$ _____. **Payment for \$ 250.00 made payable to 7HR Quarter Horses and a copy of the mare's registration papers must be returned with this contract. This \$250.00 non-refundable deposit is due and payable to 7HR Quarter Horses before or upon the mare's arrival at the breeding facility. No mare will be bred before the deposit has been paid and a completed contract is on file.**
- All other expenses, including board, vet expenses, farrier (if necessary), etc. will be due monthly. **All bills will be paid in full before the mare will be allowed to depart the breeding facility.**
- Live foal guaranteed with return privilege the following season by stallion owner only if mare fails to produce a live foal after being sent home in foal. It is understood that should the foal not stand and nurse, mare owner will be entitled to a return privilege the following year only. This guarantee applies only if mare owner notifies stallion owner within one week from death of foal. This notice must be accompanied by a statement from a licensed veterinarian. If the mare proves not to be in foal, the stallion owner has the option to rebreed the same mare the following year or refund the breeding fee, and this contract shall terminate. If the mare is to be returned and the mare owner fails to deliver her for rebreeding the following year, then any and all fees shall not be refundable and this contract is thereby cancelled. **If the mare should fail to become pregnant, lose the pregnancy or the foal dies; the non-refundable deposit of \$250.00 will be due prior to the mare being rebred the following year.** If the mare dies or becomes unfit for breeding, the mare owner may return the following year with a substitute mare approved in advance by the stallion owner.
- Diligent efforts will be made to impregnate the mare. However, if for any reason she does not become pregnant, the mare owner will not hold the stallion owner, 7HR Quarter Horses and/or their representatives liable. **It is the mare owner's responsibility to have the mare pregnancy checked within 15 days of departure from the breeding facility. 7HR Quarter Horses must be notified in writing of the mare's current status.** A pregnancy status form will be sent with the mare at departure. The breeding season will begin February 1st and close July 15th.
- It is understood that should the above named stallion die, or become unfit for service, this contract shall become null and void and the stud fee will be refunded by the stallion owner.
- A "Breeder's Certificate" will be issued by the stallion owner upon notification of the birth of the foal by the mare owner.
- All mares must have proof of a current negative Coggins test and be current on all vaccinations and deworming within 30 days prior to arrival at the breeding facility. If mare arrives without proof of negative Coggins and/or vaccination/deworming dates, it will be done upon arrival at mare owner's expense by the attending veterinarian. Each mare will receive a mandatory Strep vaccination upon arrival.
- Mare owner understands and agrees that neither stallion owner, 7HR Quarter Horses, and/or their representatives will be held responsible for accidents, sickness or death to the mare and/or foal. Furthermore, mare owner agrees that the above named parties shall not be held liable for any negligence or errors and that the above named parties may exercise their judgment in supervising and caring for mares and foals. The above named parties assume no liability for mare owners.**
- Venue for any dispute arising from this contract shall occur in Bee County, Texas.
